UF ALERT SUMMARY & AFTER-ACTION REPORT

2012

Overview

The University of Florida (UF) strives to provide an effective emergency notification system for students, faculty and staff. The system, branded as UF Alert, is consistently reviewed and measured for performance. This document contains a summary of notification activity for the calendar year as well as results from the annual UF Alert test conducted on December 5, 2012. Also attached are message content from all 2012 UF Alerts and results of a volunteer user survey included as a part of this year's test.

Summary of Calendar Year 2012 UF Alert Messages

UF issued a total of forty-four (44) messages covering eighteen (18) separate incidents during the year. The number includes an (1) annual test, three (3) timely warnings and one (1) travel advisory related to Tropical Storm Isaac. The table below lists the incidents and number of messages. Message language for each of the notifications is located in pages Attachment 1.

Survey Results Summary

For the first time, a voluntary survey was conducted in association with the December UF Alert test. A URL link to the survey was included in the test message. The survey attracted 683 respondents and asked nine (9) questions to gauge customer satisfaction and education regarding the UF Alert program.

Overall, sixty-nine percent (69%) of customers indicated having a "very satisfied" or "satisfied" opinion of the emergency notification system. In terms of content, seventy-seven percent (77%) of participants described their impression of types of emergency notifications sent as "very appropriate" or "appropriate." However, seventy-three percent (73%) of people indicated they were unaware of outdoor notifications speakers located in high-pedestrian areas of campus.




Figure 1: Overall Satisfaction of Respondents with UF Alert System.

UF Alert Test Results

In accordance with UF's Annual Security and Fire Safety Report, *Together for a Safe Campus*, a coordinated test of the UF Alert system was conducted during the fall semester. The annuanced test occurred on December 5, 2012, and activated each notification method – text messaging, email, VoIP mass notification, social media, web and RSS. The following message was sent through the integrated InformaCast portal to each method:

Test of UFAlert for Dec 5th. Feedback welcomed- http://goo.gl/BESyn. Thanks for your participation. This is only a test.

Text Messaging

Currently, UF measures performance of text messages by amount of time elapsed for Backboard to deliver all cell numbers to the aggregator. The test message performed within acceptable limits. By three (3) minute and ten (10) seconds, all numbers were delivered to the aggregator. This delivery time falls between the two previous tests and in line with historical benchmarks for UF Alert text messages.




Figure 2: Delivery Time to Aggregator by Blackboard as Measured in Seconds

Exact subscriber numbers for the University's text messaging service vary slightly each day. However, the counts for the test are provided in Table 1 and compared against the same categories for the previous test. The total numbers of subscribers participating in the system continues a small but consistent growth. As of the 2012 test, 69,407 UF community members were participating in the system.

Email

Emails delivery for the test was outstanding and significantly exceeded the performance benchmark of a ninety-percent (90%) delivery rate within twenty minutes. In fact, just over eighty-seven percent (87%) of the 83,485 emails were delivered by the three (3) minute mark. In the figure below, the results are compared to the two previous tests.




Figure 3: Percentage of Emails Delivered by Time.

VoIP Mass Notification

Messages sent to IP devices reach VoIP telephones on all three campus providers – CNS-Telecommunications, HealthNet and Housing & Residence Education. Additionally, CNS services VoIP telephones and speakers installed in academic classrooms, class laboratories as well as select outdoor locations on campus such as Plaza of the Americas and Reitz Lawn. At the time of the test, UF maintained 13,490 IP devices in the InformaCast system, which is an increase from the 12,252 devices for the previous fall 2011 test.

From the previous test in 2011, both CNS-Telecommunications and Housing & Residence Education improved their percentage of successful device activations. However, a noted decrease in performance on the HealthNet system was observed and is included in the areas for improvement. Only 69% of IP devices on the HealNet system successfully received the UF Alert test message.

Social Media

The test message was successfully posted to the UF Alert Facebook and Twitter accounts as well as UF's official twitter account. Currently, UF Alert has 2,043 "likes" on Facebook and 1,135 "followers" on Twitter. Both platforms have experienced a consistent increase over the year.

Web

Text of the UF Alert message was successfully posted on the UF homepage, including the mobile version, through the InformaCast portal. Emergency notifications appear under the "InsideUF" section of the homepage, normally with a title of "UF Alert."

RSS

Similar to the web postings, an RSS (real simple syndication) feed is created when UF Alerts are issued. Feeds are created both by the InformaCast portal and the email lists serve. Both RSS feeds functioned during the test. RSS feeds allow anyone with a third-party RSS ready, including Microsoft Outlook and Internet Explorer, to receive UF Alert messages.

Areas for Improvement

The University efforts to improve the emergency notification process and evaluate performance following each UF Alert distribution. Slight enhancements, both technical and training, are continually occurring. From the Fall 2012 exercise, performance of the VoIP mass notification system on the HealthNet system was noted.

Issue – Only 69% of the IP devices on the HealthNet system successfully received the UF Alert test message.

Status – HealthNet in coordination with EH&S and the InformaCast vendor is reviewing the issue and possible corrective actions.

NARRATIVE:

The following information was reported to the Gainesville Police Department (GPD) and is being distributed to the campus community due to the crime's close proximity to the University of Florida campus:

The GPD is currently investigating an aggravated battery incident that took place early Monday morning when the victim of the crime was discovered along the south side of Archer Road. According to information provided by the GPD, the victim was seen running in the 3000 block of Archer Road in the vicinity of the Tuscan Bend apartments at approximately 4:30am. When contact was made with the victim, it was determined that he had been stabbed and was in immediate need of medical assistance. The victim was subsequently transported to Shands Hospital.

At present, the GPD has no suspect or further information available regarding this on-going investigation. Anyone with information about the incident or who may know the man's identity is asked to call police at 352.955.1818. Those who wish to remain anonymous can call Crime Stoppers at 352.372.STOP (7867).

Avoid walking alone. On campus, use the Student Nighttime Auxiliary Patrol (SNAP), a safe campus escort service by calling 392-7627 (SNAP). SNAP operates from 6:30 p.m. to 3:00 a.m. throughout the week.

Tropical Storm Isaac and Potential Impacts on Weekend Travel

Thursday, August 23, 2012, 2:28:50 PM

Due to the uncertain impacts of Tropical Storm Isaac, the University of Florida is encouraging students, faculty and staff who might be traveling from campus to other parts of the state this weekend, especially in South Florida, to carefully consider and plan their travel accordingly.

Based upon the current National Hurricane Center forecast, exact impacts to the state are unknown at this point. However, tropical storm conditions are possible beginning in the southern most parts of Florida late in the day Sunday into Monday then potentially spreading into other areas of the state, especially along the west coast. These rain and winds from Isaac could impact return trips to the Gainesville area. Timing of a return trip may need to be adjusted to avoid hazardous weather.

Travelers should closely monitor weather conditions, any tropical watches or warnings issued and forecasts for the timeframe and areas of travel.

Information regarding Florida road and travel conditions is available from Florida 511 on the web at fl511.com or by calling 511.

Updates regarding Isaac and any associated UF actions are located on UF's Storm Watch page, highlighted on the University homepage: www.ufl.edu/tropical-weather-isaac-2012.

Any changes to UF's operating scheduling will be sent as a UF Alert and posted on the UF homepage. As always, forecasts are subject to change so the University is encouraging everyone to monitor the progress of Isaac and local forecasts.

The University of Florida Police Department (UFPD) is currently investigating an armed robbery incident that took place early Saturday morning, October 27, 2012 but was not reported until Saturday afternoon. Due to the nature of the incident and the difference between when it occurred and when it was reported, the UFPD is providing this Timely Warning.

The victim reported to UFPD that at approximately 1:15 am on Saturday, October 27, 2012 she was walking on the northeast side of Bryan Hall when she was approached by an unknown male individual. She then indicated the individual brandished a knife and demanded she give him her belongings. After she gave the individual her belongings, she fled on foot and was not harmed by the individual. After discussing the incident with friends, she decided to report the incident to police.

The suspect is described as a white male, approximately 25-30 years old, 6'01" height, 250 pounds and heavyset, brown hair but balding. The suspect is also said to have a full, long beard and a large tattoo believed to extend from his shoulder to his elbow on his right arm. During the incident the suspect was wearing a black shirt with cut off sleeves.

Walk on the side of the street facing traffic.

If a driver stops to ask directions, avoid getting close to the car.

If a car appears to be following you, turn and walk in the opposite direction. You should go to a location where other people are and get assistance. Also be sure to call police.











Text Response

I feel that some of your UF Alerts do not merit an alert. Alerts should be emergencies or threats. Power outages do not merit a UF Alert. One test to determine what merits an alert is this: if I am witnessing this event, would I call 911? A power outage would not merit a call to 911. There are other tests, of course, since many 911 calls would not merit a UF Alert either. But if a problem is not one that merits a call to 911, it should definitely *not* become a UF Alert. I was on a pay-per-text message plan on my cell phone, and I paid 20 cents each for useless texts on power outages. The useless alerts also make the true alerts less important (crying wolf). I thus terminated the sending of UF Alerts to my cell phone. You need to be more selective on what merits a UF Alert. Tim Davis, davis@cise.ufl.edu.

After hours alerts are unnecessary for those not on campus. there should be an option not to get them after hours

I think that an evaluation of the potential of harm to the UF community and the intensity of the need to apprehend the suspect needs to be carefully considered. It appears as though some of the recent assault notifications cause a feeling of over-use of the notifications.

UF alerts are most often irrelevant. Someone is chasing someone somewhere. Not of interest. When alerts have been used in the HSC they have been COMPLETELY ineffective. The people writing the alerts appear to have no knowledge of the complex. They use confusing and inappropriate descriptions and nomenclature for buildings and locations. This has led to work disruption and anxiety. In one case they referred to a bomb threat "on the third floor of Shands." Shands is not a building -- it is many buildings. We did not know which building was to be evacuated/locked down or otherwise impacted. In another case they referred to an HSC parking garage. Which one? There are several. Again anxiety was caused by an incomplete and inaccurate message. People writing the texts and emails MUST know the area they are writing about. And they must know how these buildings and garages and locations are described by the people who occupy them. For example, the UF map refers to building #1090 as the HSC admin Services Building. Both may be official names, but they are unknown to the occupants. The people that work there call it "the 1329 Building". There are many other examples of colloquial usage in the naming of building and locations. The messages are generally unhelpful as a result.

Alerts are somewhat too frequent and variable in relevance; sometimes I feel as though they are less alerts and more a way for the police to fish for leads. The problem here is that in the event of a true on campus active emergency, I feel that the alerts will be less effective and more of a "boy who cried wolf" situation.

1.) Only send alerts when it's truly important that _everybody_ know immediately. There is not a reason to wake 100.000 people at 3am for a bar fight. 2.) buy an SMS shortcode (they are cheap) so that all the alerts come from the same number. Those who care can then set a special alert tone for that number, and the rest of us can block it.

Being off campus, 280 miles to be exact, these UF Alerts do not affect me, yet they have been known to wake me up in the middle of night to let me know there was a stalker at 2 AM on sorority row on campus. As a result of being woken from a sound sleep too many times by these announcements, I have disabled the audio signal on my cell phone for texts and email. While this knocks out an important feature of my cell phone, I value my sleep more than this function. That being said, I do see the utility and relative importance of making these announcements, particularly for students. I wonder whether it would be possible to opt out of these types of announcements for

those of beyond a certain radius of campus, or for others that just don't want the extra traffic. Please advise. Thanks. Lastly, I was not allowed to NOT answer the question about how I search for additional information after receiving an alert. I believe you need to have one additional option: none. I never search for more information on these alerts, because, again, they don't affect me or my REC in southern Florida. I chose "other" and typed in "none" so that it would accept my answer and let me out of this survey.

As I mentioned above, improve the info about the location of incident. Provide a map.

I believe a phone call to the home phone and cell phones should also be options. Santa Fe College has an amazing system and is so fast in notifying individuals of harmful situations. For those of us who don't text, I believe there should be a way for the University to contact our home and cell phone numbers. If Santa Fe can do it, UF should be able to.

Thank you for being active in emergency notifications.

Text messages that are sent in the wee hours of the morning are quite disruptive, especially when several texts are sent within the span of an hour. Do we really need five or more texts at 4:00am about a robbery? If text messages are being sent, I feel that the number should be limited -- e.g., 1 per event -- and I feel there should be some consideration as to whether it's really worth sending a text to tens of thousands of people (especially when most of them are sleeping).

The alert that went out on 12/5/12 at about 11:37 am continued longer than necessary.
